#### 8.2 Assessment Criteria and Marks:

##### 8.2.1 Examinations Convocatory I

The option for the continuous evaluation system, in ordinary call I, requires the delivery, through the Moodle platform, of an essay on a topic assigned by the teacher (25%), their presentation in class (5%) and the exam writing of the contents of the course (50%), as well as obtaining 4 points out of 10, both in the essay and in the exam (or in each partial exam). Class attendance is not compulsory. Activities in class will have a weight of 10% of the final note. Participation in complementary activities will also have a weight of 10% of the final note.

##### CONTINUOUS ASSESSMENT

Exam (50%). Minimum rating 4/10.

Classroom activities (10%)

Complementary activities (10%)

Course work (25%). Minimum rating 4/10.

Presentation of the work (5%).

Examination.- Individual theoretical test (multiple choice or written) comprehensive of all the subject that will have place in the month of June (ordinary) on the day and time set by the Faculty of Sciences Business and Tourism. A minimum grade of 4/10 will be required to be able to do average with the rest of the grades. In the case of partial exams, the minimum grade for each of them will be 4. If the grade obtained in June is higher than 7/10 it can be kept for the September call. Incident examinations will be oral.

Activities in the classroom.- Consultations, tests and exercises carried out in class.

Complementary activities.- Complementary activities (conferences, seminars).

Course work.- Realization of a essay. A minimum grade of 4/10 will be required in the evaluation of the formal aspects of the essay (aesthetics, writing and use of APA style) and of 4/10 in the evaluation of the content aspects of the essay (question, argumentation and use of the concepts of the subject) and a minimum grade of 4/10 in the overall grade of the essay to be able to average with the rest of the qualifications. If the grade obtained in the essay in the ordinary call I is higher than 7/10 can be kept for the ordinary call II. The essays will be delivered through the Moodle platform before the day and time set for the exams, except in the case of incident exams, which are will deliver before these are made. The tests will be submitted to the control system of ERASER Turnitin plagiarism. The detection of plagiarism in an essay will result in a grade of zero (0) in the essay and the overall grade for the subject.

Presentation of the work.- Presentation in the classroom of the essay. In case that the presentation is not made, the qualification of the ordinary call I will be Not Presented, with independence from the rest of the ratings.

The students will be able to opt for the single final evaluation system (100%), for the ordinary call I, which must be communicated during the first 15 days of the course.
